Dangerous Building, Appliances, Systems or Conditions	Per Each Offense *Violation penalties in accordance with the adopted amendment IFC 109.4 may apply	\$500 for each offense	Following at least one documented warning or notice, this fee shall be assessed when it is determined that upon inspection there exists a dangerous condition in accordance with Section 111 Unsafe Buildings of the adopted Fire Code. This fee applies anytime a cease & desist order, stop work order, or a dangerous appliance is required to be rendered safe (red tagged out-of-service) due to negligence or similar preventable unsafe actions.

\*All inspections must be scheduled no less than 48 hours in advance
